October 26, 2023 Tegeler Residence

Commissioner Tegeler called the meeting to order at 7:05 pm.

PUBLIC COMMENT

Beaux Arts resident Julia Morse gave an update on the resident led tree advocate group. Participants have been communicating with other local tree advocacy groups and reviewing related conservation programs. The group has also been reviewing surrounding municipalities' tree codes and plans to compare them with the Beaux Arts code. They are also looking into grant funding for a comprehensive townwide tree survey. Ms. Morse reiterated that the group intends to continue to focus their efforts on research and sourcing resources and other useful information to assist other residents.

MINUTES

Commissioner Laws moved to approve the October 26, 2023 minutes. Commissioner Moloney seconded. Vote: 5 For, 0 Against, 0 Abstain. Motion carried.

COUNCIL UPDATE

At the September meeting, the Commission made a motion to request that the Council allow them to study the variance process specifically to look at adding allowances or special considerations in applications involving a historic property or large tree. The topic was discussed at the October Council meeting, but Councilmembers wanted additional information and to discuss further before giving direction to the Planning Commission.

COMPREHENSIVE PLAN UPDATE – for discussion

Town Engineer Stacia Schroeder introduced the final seven elements: shoreline, essential public facilities, tribal planning, economic development, parks & recreation, optional elements, and consistency. Town Engineer Schroeder reviewed each element and concluded that the Town currently meets all the new requirements. She shared her findings and gave a brief overview of each element and discussed them with the Commissioners.

OTHER BUSINESS

Commissioner Steve Miller reviewed the 2015 Comprehensive Plan's Character of the Community section and created a draft that would be consistent with the new state law. The Commissions will review it at the November meeting.
