BOUNDARY LINE ADJUSTMENT APPLICATION INSTRUCTIONS

GENERAL INSTRUCTIONS: Pursuant to State law, the Town of Beaux Arts Village enacted an ordinance governing short subdivisions, short plats, and boundary-line adjustments. The instructions given here are intended to describe the general requirements for filing an application with the Town Clerk. Please refer to the current Subdivision Ordinance for detailed instructions, requirements, and procedures.

The application consists of three pages of forms and one or more attachments. When completed, the applicant must submit ten copies of the application to the Town Clerk with the non-refundable application fee as set by the Town's fee resolution.

Please complete the forms and provide attachments as follows:

- Page 1: The Town will complete the top half of the page upon approval of your application. The applicant must provide the legal description of the entire tract of property for which this application is made. Please insert the legal description in the space reserved on the bottom half of the page and include the tax-parcel ID#. If additional space is needed, please attach additional sheets and number them accordingly.
- **Page 2**: The applicant is responsible for completing all of this page. <u>All</u> owners of property involved in this application must sign this page and have their signatures notarized.
- Page 3: This page must be completed by a land surveyor licensed to practice in the State of Washington. The surveyor may substitute his or her own map in lieu of this page provided the information requested in the lower portion of the form is included on that map. Please refer to the ordinance for other specific details related to the data that must be included on the map.

Attachments: Preliminary Title Report

The completed application forms must be accompanied by a preliminary title report dated within 30 calendar days of the date the completed application is submitted to the Town Clerk.
